REGISTRATION

- 5) Registration will commence on 2 January 2025 (Thursday).
- 6) Rules & regulations (R&R) are downloadable from STTA's website: https://www.stta.org.sg/tournaments/national-table-tennis-grand-finale/.
- 7) Registration shall be done via the registration link from STTA website ONLY, except for the team registration (up to 2 teams) from STTA's FULL / ORDINARY MEMBERS eligible for the discounted rate of \$87.20 per team, which had to be submitted via email to melvinluah@stta.org.sg using the STTA Full & Ordinary Members' Team Registration Form.
- 8) Registration by any other method(s) will NOT be accepted.
- 9) The closing date for registration is 23 January 2025 (Thursday) at 12:00 noon.
- 10) Registration fee paid will not be refundable.

ELIGIBILITY OF PLAYERS

11) Only players who have active STTA Individual Memberships (Athlete) are allowed to participate in this tournament. Participants with outstanding dues to STTA must be cleared by 23 January 2025 (Thursday), 12.00 noon. Otherwise, he/she will not be included for the open draw. There will be no refund of registration fee.

Team Event

- 12) Men's and Women's Team events are opened to Singapore Citizens, permanent residents and foreigners residing in Singapore with valid passes (Student Pass, Long Term Pass, Dependent's Pass, Work Permit, S Pass or Employment Pass) only. Each Team may register a maximum of ONE non-Singapore Citizens.
- 13) Classification as graded 'A+' players:
 - Permanent Resident, foreign students with student pass, employment pass, work permit holders, and / or any other pass that allow foreigners to base in Singapore
 - Players who have represented Singapore in SEA Games, Commonwealth Games, Asian Games, Olympic Games, SEA Championships, Asian Championships, Commonwealth Championships and World Championships from year 2021 – 2025
 - Former sparring partners with STTA from 2021 to 2025
 - Current sparring partners and coaches who are employed by STTA

Singles and Doubles Events

- 14) All singles and doubles events are open to Singapore citizens only.
- 15) For singles events, participants must also meet at least one of the following criteria:
 - National Team players
 - Intermediate Squad players
 - School-Within-School programme players
 - Youth Training Squad players
 - Junior Development Squad Players (born between 1 January 2013 and 31 December 2014)
 - Ranked in the Top 100 of the Overall Men's/ Women's singles national ranking as of week 48 of 2024. Please refer to the ranking list on STTA's website.

TOURNAMENT SYSTEM

Team Event

- 16) A team shall consist of a minimum of 3 players and maximum of 4 players.
- 17) The team match shall be played according to the Olympic System (Best of 5 matches: 4 singles and 1 doubles). The order of play shall be:
 - i) Doubles B & C vs Y & Z
 - ii) A vs X
 - iii) C vs Z
 - iv) A vs Y
 - v) B vs X

Note: Player A, B, C and X, Y, Z must be nominated before the match.

18) Please refer to table below for example of team configuration.

- 19) All Team Managers/Captains must report to officials' table at least **30 minutes before** the scheduled match to collect their team line-up.
- 20) Teams shall submit the line-up form 25 minutes before the scheduled time.
- 21) Teams whose team line-up are not submitted 10 minutes before the scheduled time will have their line-up pre-filled in descending order according to the team registration list.
- 22) There shall <u>not</u> be any grace period. If a player is not present for his or her match in a team match, he or she will concede a walkover for that tie and the match will proceed to play the next preceding tie.

- 23) The name of the team captain, playing or non-playing, shall be designated beforehand to the umpire.
- 24) Substitution(s)/Addition(s) of players are <u>allowed</u> before <u>14 February 2025 (Friday) at 12:00noon</u>. The new player(s) must not be from any of the teams already registered for the competition.
- 25) Should there be less than 6 participating teams, team events shall be played on a single group round robin system. All matches shall be played to the best-of-5-games of 11 points each.
- 26) When playing tables and umpires are available, teams will have to play their matches concurrently.

Singles and Doubles Events

- 27) The number of seeded players/pairs will be determined by Tournament Referee.
- 28) The format of play will be dependent on the number of entries. If there are more than 16 entries, it shall be played in a single knock-out format. Up to the quarter finals, it shall be played to the best of 5 games. From quarter finals onwards, it shall be played to the best of 7 games.
- 29) The doubles events shall be played with a single knock-out system to the best-of-5 games of 11 points each.
- 30) Any event with less than EIGHT (8) entries may be cancelled. If an event is cancelled, the registration fees will be refunded.
- 31) All players must report to officials' table at least 30 minutes before the scheduled match. Player shall concede a walkover, if the player is not on court at the scheduled time after the match has been announced on court. There shall not be any grace period.
- 32) Each player is allowed to have an accompanying coach who must have a valid STTA Individual Membership (Coaches), to provide side coaching for their match(es). Proof of valid STTA Individual Membership (Coaches) must be shown to officials upon request. Please note that processing time for STTA Individual Membership (Coaches) application may take up to 3-4 weeks.

GENERAL

- If the player fails to show up at any stage of the event and is unable to produce a valid written explanation within 7 days from the last day of the competition, he/she will be awarded penalty points per "no-show". The number of penalty points will be calculated as the double of the rating points the player is supposed to get for the stage of the event he reached. For players being awarded penalty points, rating points shall still be awarded based on the stage of the event he reached. For all the walk-over matches, prize money and placing shall be forfeited.
- Any withdrawal from the tournament must be emailed to Mr Melvin Luah of STTA at melvinluah@stta.org.sg before the closing time of the registration.
- 35) The tournament shall be run in accordance with the latest rules and regulations of the International Table Tennis Federation (ITTF). Rules and regulations can be downloaded from www.ittf.com.
- 36) The ITTF approved 3-Star 40+ white balls shall be used during the tournament.
- 37) No white apparels (shirt and shorts) are allowed. Players who fail to conform to this dress code will not be allowed to play.
- 38) Players from the same team and doubles pairing shall wear shirts that are of sufficiently same colours. From Quarter-Finals onwards, players from the same team and doubles pairing must wear the same attire.
- 39) Players are not allowed to use mobile devices to make or take calls at all times during their match(es).
- 40) Racket control will be implemented in this competition. It is the responsibility of the players to ensure their racket coverings will pass all parameters of the racket control tests. Any player who failed three compulsory racket testing before or after match in the tournament will be disqualified from all events of the tournament. The Disciplinary Committee will decide whether to award the prizes won prior to his/her disqualification. Please refer to Annex A for more information.
 - Racket submission time: 20 minutes before match.

FIXTURES

- 41) Individual seedings:
 - Men's Singles & Women's Singles: Seedings will be first based on the World Rankings and then followed by STTA National Rankings.
 - Men's Doubles, Women's Doubles and Mixed Doubles: Seedings will be based on the total points of the Ranking Positions of the pair (Ranking Position will be based, first on World Ranking, followed by the STTA National Ranking).
- 42) The <u>complete entry list</u> shall be published on STTA Website (www.stta.org.sg) from **27 January 2025 (Monday)** onwards. Any <u>discrepancy or omission of entries</u> must be brought to the attention of STTA by **2 February 2025 (Sunday)**. Strictly **no changes** shall be made after the omission check.
- 43) An <u>open draw</u> of tournament fixtures will be conducted on **6 February 2025 (Thursday)** at OCBC Arena Hall 6 from 7:00pm onwards. All are welcome to witness the draw.
- 44) <u>Fixtures and match schedules</u> will be displayed on STTA Website (<u>www.stta.org.sg</u>) from 10 **February 2025 (Monday)** onwards. Kindly take note that it is the responsibility of the player to check for the latest competition fixture and schedule.

PRIZE PRESENTATION

- 45) The Prize Presentation Ceremony shall be held on **2 March 2025 (Sunday)** immediately after the finals of the last event.
- 46) All prize winners **MUST** be present personally at the ceremony in neat attire (no singlet, slippers and sandals) in order to receive their prize/s. Player who concedes walkover will not be entitled to receive any prizes.
- 47) The Organizing Committee reserves the right not to award the prize money and trophy if Regulation 45 is breached. In addition, if a player who must attend the prize presentation failed to show up, the rating points that he should have obtained from the event will be forfeited.
